b. Review of Suns Sponsorship for 2016

Did we meet the goals we expected to reach with the Suns agreement this season? Discussion of the 2016 experience was heard. The Suns have put forward an agreement for the 2017 season.

A survey was put together by the Jr Committee for the parents, coaches and the Jr Club Directors on the experience. The survey will be edited and then sent out. We will leave the survey open for 2 weeks. The info will then be available for the Junior Forum on April $3^{\rm rd}$. While conducting the 50/50 raffle at the arena during our tournament Ron heard from parents who were very appreciative of the experience. For them it became more like a college setting than a national qualifier.

We will look to post the powerpoint on the website that was supposed to be shown at the Suns game.

If the parents are for it then the information will be given to the club directors and they can build this into their budgets.

Inquire with Aaron about boys participating in the Suns sponsorships.

c. Arizona Senior Olympics Subsidy

The Senior Olympics in Phoenix is being held March 12-13. Charlie Eckman reached out to the Region to give junior clubs the opportunity to do some community service and raise some funds by providing linesman, scorers, libero trackers/score flippers and R2s for the matches of the Senior Olympics. The Region officials are also going to be tapped to be R1s for the matches. This is an area in which we can help subsidize the fees for the officials and the fundraising efforts of the teams. This is also an area we can use development grant account funds to grow the Senior population playing volleyball. Charlie would like a contract from the Region to cover the subcontract officials. Should this be a continuing relationship for this organization?

Motion 4: Move to subsidize the officials' fees for the Senior Olympics. (Hudson/Pelham) Motion Carries

The contract will ask ASO to provide \$20 per full match and \$10 for each set. This arrangement will be reevaluated for next season.

d. NBC Gold Map and Open Court

Documents from USAV were provided regarding the NBC Gold Map and Open Court programs that will coincide with the Olympics in Rio. It is a grassroots member growth project for USAV and the RVAs.

Need to talk to AIA about the Open Court concept – in the event some high school player shows up.

Insurance coverage for the Open Court portion – request a waiver for those not registered.

e. By-Laws Change

Change the terms of the Board positions to 3 years to match the junior Committee rotation. Rationale: this puts all the Board positions on the same term length. The terms would be staggered as discussed.

Motion: Move to revise the By-Laws to stagger the terms of the Board of Directors elections and increase the length of terms to 3 years.

This is the first reading of this motion. The motion will be considered at the next meeting.
